## Human Life PAC Rules (Since 1980)

• All candidates must submit a completed questionnaire (each election cycle) to receive an official assessment or endorsement.

• \*When an incumbent faces a pro-life challenger, previously endorsed pro-life incumbents take precedence over new candidates;

• \*The new candidate is listed as in "100% Agreement" status with *Human Life PAC*.

The following candidates completed 13 questions. Answers not consistent with our position are ranked as indicated:

- **1** Missed: Substantial Agreement
- 2 Missed: Near Agreement
- 3+ Missed: Partial Agreement
